Building Empathy Instead of Forcing Apologies

At snack time Claire reaches across the table for the bowl of strawberries and as she does she bumps Jackson's milk. It spills and both Jackson and Claire look to the teacher, waiting for her response.

Teachers must choose how to respond to these types of situations each day. One common response teachers use is to tell Claire to say she is sorry. Saying sorry is sometimes used as a quick way to attempt to manage the situation. Teaching children how to make amends is another approach that can be practiced in early childhood and used life-long. Making amends and feeling remorseful requires the use of empathy.



Empathy is the ability to understand and share the feelings of another, which requires developing a range of social-emotional skills. Consider some of the ways you can encourage the development of empathy:

- **Empathize with children** *Are you feeling sad because your Grandma left? It is sad when Grandma has to go. I'll sit in the rocking chair with you until you are ready to play.*
- **Talk about the feelings of others** *Jaylen is feeling mad because you knocked his blocks down.*
- **Offer children suggestions about the ways they can show empathy** *Please ask Jaylen if you can help him fix his building.*
- **Read books about feelings and emotions** *The Feelings Book by Todd Parr Flabbersmashed About You by Rachel Vail Baby Happy, Baby Sad by Leslie Patricelli*
- **Be a role model** *Children learn from your examples. Be kind, respectful and caring as you interact with children and adults.*
- **Validate and acknowledge the emotions of children** *Feelings are part of life for everybody. Avoid rushing to fix every problem immediately while instead acknowledging the feelings of a child. You were disappointed when it was time to come inside. I understand and it's okay to feel disappointed. When you are ready, you can join us at the snack table.*

Think through the use of, "I'm sorry." We often insist children say this as a way to fix what they have done or to take responsibility for their actions but many children do not know what these words really mean. A more meaningful approach would be to help children learn how to focus on the feelings of the other person. Developing empathy takes time and is a skill that children will continue to develop throughout their life.

"Oops, it looks like we had a spill. Jackson you look a little worried.

It's okay, Claire and I will help. Claire, can you get some paper towels to clean up the milk, and I'll help Jackson find a dry shirt."

Recycled Container Printing

To do some recycled container printing you'll need:

- A selection of containers and trays that have interesting bottoms
- Some paint and some containers to put the paint into
- Some rollers or paint brushes
- A BIG sheet of paper
- A wet cloth for cleaning up drips
- Somewhere to dry your creations



We found rollers were the easiest way to apply paint to the bumpy surfaces, but you could use a regular paint brush, or try dipping the containers into a large tray of paint. We managed to find containers with lots of interesting textures. Look for trays with different shaped indents, containers with ridges or lines and even little containers like yogurt tubs make interesting prints. We had success with meat trays, packaging from biscuits and frozen food packaging.



When covered in paint and pressed onto the paper they containers made an array of weird and wonderful printed patterns.

June 13, 2018: Governor Walker Announces Child Care Subsidy Rate Increases

MADISON – Governor Scott Walker today approved substantial positive changes to the Wisconsin Shares child care subsidy program by putting an additional \$10 million annually in the pockets of low-income families who need affordable child care to support employment.

The targeted rate changes will assist parents in three significant ways:

Raise the subsidy rate by 5 percent for infants (ages 0-2) and for young children (ages 2-4) to help parents afford care during their children's early years, which are often the most expensive for parents and providers.

- Establish a statewide minimum subsidy rate of \$5/hour for infant care in licensed providers, making child care more affordable for young families, especially in rural areas.
- Reduce the penalty imposed on parents who choose a 2-Star provider, putting an estimated additional \$2 million in the pockets of parents for whom a 2-Star provider is the best choice or their only local option. "For Wisconsin to continue to thrive, we need to continue to remove barriers to work," said Governor Walker. "Ensuring that parents have access to affordable, quality child care empowers them to remain in the workforce and helps our children get the early education they need to be successful in school."

These rate changes continue Governor Walker's strong investment in early childhood education following his lifting of the child care rate freeze imposed in 2006. Since taking office, Governor Walker has now made multiple child care rate increases, approved higher quality incentive payments for 4 and 5 Star child care providers, and ended the "child care cliff" by creating a sliding scale for income eligibility for current participating in the Wisconsin Shares program.

Sales Tax Holiday for August 2018!

What does this mean for the general consumer?

A sales and use tax exemption is created for sales of certain items during a **five-day period** in August 2018. The temporary exemption period, referred to as a sales tax holiday, will begin at **12:01AM on August 1, 2018, and continue through 11:59PM on Sunday, August 5, 2018.**

During the sales tax holiday, the following items are exempt from Wisconsin sales tax (list is not all inclusive):

- *School supplies, if the sales price of any single item is \$75 or less
- *Clothing, if the sales price of any single item is \$75 or less
- *A computer purchased for the purchaser's personal use, if the sales price of the computer is \$750 or less
- *School computer supplies purchaser's personal use, if the sales price of any single item is \$250 or less

During the sales tax holiday, the following items are taxable for Wisconsin sales tax purposes (list is not all inclusive):

Chicken or Turkey Taco - USDA Recipe D-130C for CACFP

Makes: 25 Servings

Ingredients:

1/2c 1T 1t Fresh onions, chopped	2 1/4t Ground cumin
1 1/4c 2T Frozen corn	3/4t Paprika
2 1/4t Garlic powder	3/4t Onion powder
1/2t Salt	2qt 2c Frozen cooked diced chicken, thawed, 1/2" pieces
1t Ground black pepper	2qt 2c Frozen cooked diced turkey, thawed, 1/2" pieces
3/4c Canned no-salt-added tomato paste	1qt 1/2c Brown rice, long-grain, regular, dry, parboiled
3c Water	1qt 3c Fresh lettuce, shredded
1T Chili powder	1 1/2c Fresh tomatoes, chopped
2 1/2c Reduced-fat Cheddar cheese, shredded	50 each Whole-grain yellow corn taco shells

**Directions:**

1. Combine onions, corn, garlic powder, salt, pepper, tomato paste, water, and seasonings in a large stock pot. Heat uncovered over medium heat for 5 minutes. Stir well. Bring to a boil.
2. Add chicken. Reduce heat and simmer for 25-30 minutes, stirring occasionally.
3. Critical Control Point: Heat to 165 F for 15 seconds or higher.
4. Critical Control Point: Hold for hot service at 140 F or higher.
5. See B-03 for recipe ingredients and directions. Set rice aside for step 9.
6. For topping: Combine lettuce and tomatoes. Toss slightly. Set mixture aside for step 12.
7. Set cheese aside for step 13.
8. Assembly (2 tacos per serving):
9. First layer: Using a No. 8 scoop, divide equally between two tacos, 1/2cup (about 4oz) rice on bottom of taco shells.
10. Second layer: Using a No. 30 scoop, spread 1/8 cup (about 1 1/2oz) chicken mixture in each taco shell.
11. Transfer tacos to a steam table pan (12"x20"x2 1/2").
12. Third layer: Using a No. 10 scoop, divide equally between two tacos, 3/8 cup (about 1 1/2oz) lettuce and tomato mixture on top of chicken mixture.
13. Fourth layer: Using a No. 40 scoop, divide equally between two tacos, 1 Tbsp 1 tsp (about 1/3oz) shredded cheese on top of lettuce and tomato mixture. OR instruct students to "build" their own tacos.
